





Dr. Stager, an Osteopathic physician, has been a holistic general practitioner in West Palm Beach since 1990. His educational background includes 4 academic degrees, 4 medical Fellow degrees, and 2 board certifications: a BA in Philosophy and Master of Science in Anatomy from Rutgers University, NJ, an undergraduate teaching Fellowship in Osteopathic Manipulative Medicine and Doctor of Osteopathy from Nova Southeastern University College of Osteopathic Medicine, FL, and MPH from ATSU, Kirksville, MO. He completed a general internship in 1990 at Humana Hospital, Hollywood, FL. His medical acupuncture training was through UCLA, Los Angeles, CA.

He has two board certifications: Board Certified in Neuromusculoskeletal Medicine and Osteopathic Manipulative Medicine by the American Osteopathic Board of Neuromusculoskeletal Medicine, and Board Certified in Family Practice by the American Osteopathic Board of Family Physicians. Prior to relocating to Montana, Dr. Park led the development of RVUCOM's Southern Utah additional location campus where he served as Vice President and Campus Dean seeing his inaugural class graduate in 2022. Dr. Park has been in formal medical education for over 20 years starting in Queens, New York, where he spent over 30 years of his formative life in America. Dr. Park moved to Las Vegas in 2005 and spent 10 years having numerous teaching

and administrative roles at the newly established Touro University Nevada College of Osteopathic Medicine. One of Dr. Park's proudest accomplishments was creating the Family Medicine Residency Program at Valley Hospital Medical Center in central Las Vegas, where he served as the Program Director for nine years. 




## Solutions Center Floor Plan
