No matter who his patient was, homeless or millionaire, they always received the very best of care. He told me how that he as a new physician had to pay bed rental fees at the old Oklahoma Osteopathic Hospital for hospitalized patients as a way to pay for the hospital building itself. His sacrifices continue to pay off to all those physicians he has helped train and make training available.

Thank you to all those who continue to train the next generation physicians.

As a final word to all our physicians, your profession is a calling, and your calling is honorable. Keep up the good work and pass along your wisdom to those who come after you. Thank you and God bless.

OSU Center for Health Sciences Announces Leadership Changes

On April 23, 2021, the Oklahoma A&M Board of Regents selected Dr. Kayse Shrum, president of OSU Center for Health Sciences and dean of the College of Osteopathic Medicine, to be the next president of Oklahoma State University following the retirement of President Burns Hargis on July 1, 2021.

"I am humbled and honored by this announcement," said Shrum. "I am also thrilled because outside of my dear family, OSU has a special place in my heart. Leading the OSU Center for Health Sciences and helping students, faculty and staff come together to create something truly impactful to our state has been immensely rewarding for me."

As the first woman to lead Oklahoma State University, Shrum has overcome barriers throughout her professional career. She has served as president of OSU-CHS since 2013, and her selection at the time made her the youngest and first female president and dean of a medical school in the state of Oklahoma.

Under her leadership, the institution has experienced unprecedented growth. Student enrollment doubled and she led the construction of the A.R. and Marylouise Tandy Medical Academic Building.

In 2019, she helped secure \$197.5 million from Purdue Pharma to create the National Center for Wellness and Recovery for addiction treatment and research. A strong supporter of collaborative partnerships, Shrum also worked with Cherokee Nation leadership to establish the OSU College of Osteopathic Medicine at the Cherokee Nation, which opened fall 2020.

In June, Hargis announced that Dr. Johnny Stephens, Pharm.D., will be interim president of OSU-CHS effective July 1. Stephens, who has been part of the leadership team for seven years, has served as vice president for research, chief operating officer and most recently the senior vice president. Also effective July 1, Dr. Dennis Blankenship will become interim dean of the OSU College of Osteopathic Medicine. He has been active in administration as senior associate dean and previously served as chair of emergency medicine. He formerly served as chief of staff at OSU Medical Center.

"I am extremely proud of the progress and accomplishments of CHS under the leadership of Kayse Shrum and her entire team," Hargis said. "The academic health care center has been stabilized and will soon grow to include a veterans' hospital and mental health hospital, which will expand the care for veterans and our most vulnerable populations while increasing the number of resident physicians in Oklahoma."

Paul F. Benien, Jr., DO, FACOS, sadly passed away in November 2020 but he deserves honor and recognition for the incredible legacy he has left. After earning his undergraduate degree from the University of Oklahoma, Dr. Benien received his medical degree from Des Moines University's College of Osteopathic Medicine graduating in 1966.

Upon completion of a one-year internship at Tulsa Regional Medical Center, Dr. Benien served as a captain in the U.S. Army Medical Corps during the Vietnam War. Back stateside, he completed his residency training in general surgery at the Dallas/Fort Worth Medical Center in Grand Prairie, Texas, finishing in 1974. Dr. Benien returned to Oklahoma and underwent extensive training in cosmetic surgery and became a fellow of the American Academy of Cosmetic Surgery.

Dr. Benien founded the Cosmetic Surgery Center in Oklahoma City to help patients improve their self-image and self-esteem. Dr. Benien proudly served his profession on the OOA Board of Trustees and as president from 1993 to 1994. He was appointed for two terms by two Oklahoma Governors to the Oklahoma State Board of Osteopathic Examiners. He desired to help others and give back to the next generation. With his passion and kindness he was loved by all who had the privilege of knowing him.

After graduating from Central State **LeRoy E. Young, DO, FAOCOPM** *dist.* attended the University of Oklahoma where he received a Bachelor of Science degree in pharmacy in 1969. After practicing for several years and owning his own pharmacy, Dr. Young attended the Kansas City College of Osteopathic Medicine.

Upon graduation from KCCOM, he returned to Oklahoma City where he interned at Hillcrest Hospital then began private practice in Moore. Throughout his career, Dr. Young has given back to his profession and strived to make it better for the next generation.

He was a founding member of the American Osteopathic College of Occupational and Preventive Medicine, and in 1984, he was one of the first to be certified in Occupational Medicine by the AOA. He served as the president of the College of Occupational and Preventative Medicine in 1988-1989. In 1990 he was appointed to the certification board of AOBPM and continues to serve today. He served as president of AOBPM from 1992 to 2007. He was awarded Fellow of American Osteopathic College of Occupational and Preventative Medicine in 1985 and Distinguished Fellow in 2013.

Dr. Young has served on several national committees and bureaus of the American Osteopathic Association. He was a member of the Oklahoma Osteopathic Association Board of Trustees from 2002 to 2013 and served as president from 2011 to 2012. He was a board member of the Oklahoma Health Professionals for Impaired Physicians from 2007 until 2012, and has served on the OOA-OSU Advisory Council, appointed by President Burns Hargis from 2005-2016.

He is currently legislative chair for the OOA, chairman of OOPAC and also serves on the board of the Oklahoma Educational Foundation for Osteopathic Medicine. In addition, last year Dr. Young helped the OOA Board of Trustees transition the leadership of the Association. His leadership guided the OOA through the transition impeccably and they are incredibly appreciative of his service.


We sadly lost **Former Senator Mark Snyder** last year but his legacy lives on and we did not want to miss the opportunity to publicly recognize and thank him.





LEGISLATIVE & ADVOCACY

This year the Oklahoma Osteopathic Association has worked tirelessly to safeguard the interests of our members across the state and to advocate against policies that would negatively impact your patients in Oklahoma. Many of you joined us in these efforts, participating by calling and emailing your legislators and joining with OOA leadership in visits to the state capitol.

Thanks to your hard work, we were successful in defeating many bills this session that would have had major impacts on physician scope of practice. Notably, Senate Bill 478 was stopped in the HHS Committee; this bill would have expanded prescriptive authority for advanced practice registered nurses, and added the definition of the term "licensed practitioner" under the Oklahoma Pharmacy Act. House Bill 2164, which would have added psychologists to the defined list of occupations who can call themselves "physicians" was also defeated, failing to make it out of the House, along with HB 2595 which would have increased the period of time a physical therapist can treat a patient without a referral from 30 to 60 days. Senate Bill 516, which would have allowed physicians to supervise an unlimited number of physician assistants died in conference. These are only a handful of the bills the OOA and our allies advocated against during this session.

Perhaps the biggest fight we faced this year was the Health Care Authority's attempts to implement "SoonerSelect", a managed Medicaid program that would essentially outsource management of Oklahoma's Medicaid population to big, multi-state (in some cases multinational) insurance companies, putting even more delays, denials, and red tape between the patient and their doctor. The OOA was a named petitioner in a lawsuit to stop this plan from going forward without proper legislative approval and appropriate rulemaking: this lawsuit was successful at the Oklahoma Supreme Court, with a 6 to 3 opinion handed down in our favor. With our coalition allies and the involvement of concerned members, we were also successful in getting a guard rail bill (SB 131) put in place before this court victory to protect against the negative effects of managed care should it go through. It is very likely the OHCA will push forward with managed care this fall and in 2022, so the OOA will continue to participate in the fight against this plan.

The impressive success of the OOA's advocacy efforts this year could not occur without the passionate engagement of our members. It is your relationships with your local representatives and senators that allow our organization to effectively fight for your interests. As the only organization within our state advocating for the Osteopathic Profession, the OOA is grateful for your support and involvement now and in the future.

Brothers Graduate Medical School Together

This summer is just the second time in nearly 25 years that brothers Tyler and Taylor Snyder aren't living under the same roof. Both graduated together from the OSU College of Osteopathic Medicine on May 15.

The brothers — who are members of the Cherokee Nation — grew up in Westville, Oklahoma, and have been roommates as they worked their way through medical school. Tyler, who is a year and a half older than Taylor, was attending the University of Arkansas in Fayetteville studying poultry science before being joined by his brother there, who was pre-med.

"I had the idea my senior year of high school that I wanted to be a doctor," Taylor said. "I had an ear infection that ruptured my ear drum. As I was sitting in the doctor's office I thought 'This is something I could do."

Tyler said he soon knew that poultry science wasn't his future, so he decided to check out medicine with his brother.

Both brothers volunteered at a veteran's hospital and shadowed several physicians in the Cherokee Nation Health System, where they had received care in the past.

"The Cherokee Nation has been instrumental to us. We shadowed with them, we've utilized the health care system, we've been awarded scholarships. We both received an Indian Health Service Scholarship," Tyler said. When it came time to apply to medical schools, both brothers had different reasons for choosing OSU.

"All but one of the doctors I shadowed was a DO and I had great experiences with all of them. It was important for me to go to a DO school," Tyler said.

For Taylor, it was more about where he felt the most at home. "I came to OSU and everyone was friendly and supportive. OSU was definitely the best fit for me," he said. Tyler and Taylor said having each other there made them better students. "My brother was always a year ahead of me and he always made good grades so it pushed me to do just as well, if not better," Taylor said.

It was the same for Tyler. "Taylor pushed me a lot to make better grades in our undergraduate years. I think that helped me push myself in medical school," Tyler said.

They were also each other's study partner and cheerleader. "Med school is a very stressful time. Having that built-in support system was really helpful," Taylor said.

In July, both begin their residencies in different cities. Tyler





will begin his Family Medicine residency at the Cherokee Nation Outpatient Health Center in Tahlequah.

"I liked the clinic and I felt I could make a bigger impact there," Tyler said. "It's important to give back. So many people have helped us along the way at the Cherokee Nation."

Taylor matched with OSU Medicine Pediatrics and will begin his residency this summer in Tulsa.

"I always wanted to go into pediatrics. It was inclination when I was 17 years old," Taylor said. "But eventually I want to go back as well and practice near home."

While they were close before, Tyler said the experience of going through and now graduating from medical school together just brought them even closer.

"Even though we went to high school and undergrad together, medical school is a different animal," Tyler said. "We were forced to rely on each other. I wouldn't change it."



In Memory: Deaths in the Osteopathic Family



Sam Stauffer, age 68 of Tulsa, OK passed away June 3, 2021 in Tulsa. He is survived by his loving wife, Patty and sons, Joey and Jon.

James S. Stauffer (Dr. Sam) was born April 16, 1953 in Shawnee, OK, to James S. and Helen Stauffer. He married his high school sweetheart, Patricia Greene, in 1975. Sam attended Altus Junior College, Southwestern Oklahoma State University and the

University of Oklahoma where he received his Bachelor of Science degree in pharmacology.

After graduating from pharmacy school, Sam attended Oklahoma College of Osteopathic Medicine in Tulsa (now OSU College of Medicine), in 1980 and completed his internship at OCOMS in June 1981. One day later, he set up his practice in Oologah, OK, along US 169, where he created a thriving medical facility out of an old bait shop. He was ultimately board certified in family medicine. The Oologah Family Clinic soon became an established and well-known resource for ailing people and was crucial to the area's development.

For nearly 40 years, Sam focused on the health, welfare and medical needs of the Oologah community, becoming one of the most prominent citizens and leaders of Rogers County. In addition to a full schedule of patients, he was the physician for the Oologah Mustangs athletic teams as well as the doctor for PSO/AEP. He served as the Rogers County, OK, medical examiner and was chief of staff at Claremore Regional Medical Center. He also served on the Board of Directors for Lakeside State Bank and was a past president of the Oologah-Talala Public Schools Foundation and past president of the Oologah Chamber of Commerce -- all the while serving as assistant clinical professor at the OSU College of Osteopathic Medicine.

Sam thrived on helping others and providing medical care to the families in the Oologah-Claremore area. He helped an incalculable number of people with everything from minor injuries to major, multi-people emergencies. The patients he had as children became parents themselves and returned to the Oologah Family Clinic as a new generation.

As accomplished and engaged as he was in his profession, Sam loved nothing more than spending time with his friends and family, especially his grandchildren. Sam semi-retired in 2018 but was still active in medicine.

Sam was preceded in death by his mother and father. He is survived by his wife, Patty; two sons, Joey (and wife Whittney) of Tulsa, OK and their children, Meryl and Sam; and Jonathan (and wife Whitney) of Tulsa and their two children, Stella and Jack; two sisters, Susie Sunderland of Utah and Sara Carter of Tulsa; as well as many nieces and nephews.



Dr. Fredrick W. Boling, 94, was born in a farmhouse west of Edmond, Oklahoma to Fredrick W. Boling, Sr., and Florence Hargrave Boling on November 11, 1926. He transitioned to Heaven on April 26, 2021. He accepted Jesus at age eleven. His initial 8 years of education were spent attending Deer Creek Consolidated School. The family moved to a farm near Big Cabin, Oklahoma in 1940. He graduated from Big Cabin High School in 1944. He entered premedical studies at Northeastern Oklahoma

A & M College, Oklahoma University, and then University of Central Oklahoma, where he met and later married his sweetheart Wilma Lee Cave in 1950. He graduated a Doctor of Osteopathic Medicine from Kansas City University of Medicine and Biosciences in 1952. After intern and surgical training, Fred was certified in General Surgery, and practiced in Wyoming, Texas, and Oklahoma.

In 1965, Governor Clifford Hansen appointed Fred to serve a 4-year term on the Wyoming State Board of Medical Examiners. In 1968, he was granted Degree of Fellow by the American Academy of Surgeons. He was a lifetime member of the American Association of Physician Specialists (serving as President in 1972-73), American Association of Osteopathic Surgeons, American Osteopathic Association, Oklahoma Osteopathic Association, and American Medical Association.

He served as Chief of Staff at hospitals in Wyoming, Texas, and Oklahoma. He spent the last 16 years of his surgical practice in Fairfax, Oklahoma. During that time, he also served as Adjunct Clinical Professor of Medicine and Surgery at Oklahoma State University College of Osteopathic Medicine and was on the admittance board of student selection. He was the Osage County Medical Examiner for 4 years.

Fred and Wilma moved to Hot Springs Village, Arkansas upon retirement in 1993. They celebrated their fiftieth wedding anniversary with a three-week European tour and their sixtieth anniversary with an Alaskan cruise. During retirement he wrote and published four historical novels, many short stories, and magazine articles. He was active in Western Writers of America and served as President of Hot Springs Village Writers for several years. During his lifetime he was, among other things, a mayor, author, publisher, pilot, house renovator (in Riverton, Wyoming), hunter, outdoorsman, cook, member of the Hot Springs Village Barbershop Quartet, website builder, actor, golfer, kit car builder (Mercedes 1929 Roadster), historian, crossword puzzle master, avid reader, great joke teller with a dry quick-witted sense of humor and the greatest listener of all.

Fred was preceded in death by his parents, sisters Larraine and Shirley, brother Donald, and grandson John Blassingame.
