Annual Meeting Minutes

April 25, 2019

- 1. The meeting was called to order by Rebecca Lewis D.O., president. Dr. Lewis recognized the national visitors and introduced Robert C Deluca D.O. FACOFP *dist*, national ACOFP president.
- 2. Dr. Deluca started opening remarks by stating this is the first state he has visited since becoming president. He outlined upcoming changes including changes certification, advocacy and the hiring of a new Executive Director, Bob Moore. He talked about the future of the osteopathic profession and the preservation of osteopathic identity.
- 3. Minutes from the annual meeting of 4/26/2018 were approved.
- 4. Michael K Cooper D.O. FACOFP gave the treasurer's report. The Financial report outlined all credits and debits since the last annual meeting. There is currently a balance of \$72,478.84 in the bank. The financial report was improved.
- 5. Dr. Lewis gave the report from the Congress of delegates and the annual meeting. Resolutions included gun safety policy, allowing MDs to join the ACOFP and maintaining the osteopathic component in board exams. Athena Chatzigiannidis, OMS IV was elected student governor on the national Board of Governors of ACOFP.
- 6. Bret Traxler, OMS I, student chapter president, gave the student report. He reported that the students were trying to hold monthly meetings with a variety of speakers from different facets of family medicine in order to highlight the broad-spectrum of the specialty. He also stated that the students wished to hold a back-to-school barbecue in August.
- 7. Dr. Lewis gave the nominating committee report: David good D.O., president (automatic), Erin Balzer, D.O., president elect; Jason Hill, D.O., VP; Rebecca Lewis, D.O., secretary/treasurer, Lane Subera, D.O. FACOFP, trustee; Tim Moser, D.O. FACOFP, trustee; Duane Koehler, D.O. FACOFP*dist*, trustee, Trudy Milner, D.O., trustee. All were elected in block by acclimation.
- 8. Dr. Deluca administered the office to Dr. Good.
- 9. Dr. Good presented the presidential plaque to Dr. Lewis. Dr. Lewis then honored Dr. Cooper for his 19 years of service as secretary/treasurer of the state society. He will be presented with an A. T. Still bust when it arrives.
- 10. Dr. Good adjourned the meeting.
